Taking a Stand for Our Members and Seeing Where It Takes Us

In August of 2009 the WCIECA Board of Directors reviewed the committees that represent our chapter members and added a manufacturer's committee liaison. The responsibility of a committee chairperson is to take the lead and garner member involvement. The new committee was highlighted in the May 2010 WCIECA Newsletter. After this newsletter several manufacturers contacted the WCIECA in June 2010 regarding a specification used to assess product qualifications and asked the Western Chapter to issue a formal complaint on their behalf. This was done and modifications changed in the state's specification to address the formal complaint.

In the process one state agency inquired if the erosion and sediment industry had standards for erosion and sediment control material types. During additional conversations and correspondence with other state agencies it was suggested that the IECA, as an Erosion and Sediment organization develop basic standards for E&S control material types that all QPL (Qualified Product List) state department agencies could use and refine for state, county and city differences.

The WCIECA took these suggestions as a great opportunity for the IECA organization to come up with a "back to the basics" program; pulling from the list of uniform basic BMP products and procedures; ideas from organizations such as ECTC and others to help guide QPL state departments making decisions when it comes to the erosion and sediment control industry. WCIECA championed this opportunity and approached the IECA Board of Directors to take the lead which they voted to do in the 2011. Following the vote the IECA put a call out across all industries that would have a vested interest in helping establish basic standards and participate on a task force to develop guidelines for the new IECA Standards & Practices Committee.

At the same time the WCIECA committee liaison addressed with other stake holders how basic standards could be established without bias or unfair influence. Organizations were contacted such as ASTM, EPA, NTPEP, Manufactures, Consultants, and Universities to help guide us on this quest for basic standardization. From all of this it brings us to date where the Standard and Practices Committee has set up a road map to move forward to set committee makeup and interaction criteria.

As a first step, the IECA would collect standards, practices and definitions from across the US that are comprehensive and have been accepted locally or regionally as being "good" standards, practices or definitions. This information would be compiled into a searchable library for use by all IECA members. No evaluation would be made of the standards, practices or definitions at this step, as this database would simply be a clearing-house of information.

IECA's Standards and Practices would begin building foundational relationships with other organizations involved in setting or evaluating standards, practices and definitions related to sediment and erosion control.

The following step would be to evaluate the "completeness" of the information collected. Data gaps would be identified.

IECA's Standards and Practices Committee set its final draft guidelines and obtained approval from the IECA Board of Directors in December of 2011. Design Methodology, Evaluation Standards

and Terminology Guidelines were finished April of 2012, three sub-committees were formed and chair persons were selected in late April 2012.

Definitions and methodologies were picked and given to sub-committees in May 2012. Sub-committees discussed in June 2012, Sub-Committee rough draft discussed in full committee in July 2012 and sent back to sub-committee for changes and review.

To date the Standards and Practices has one definition finished, one definition in rough draft form for full committee review, one long term and one short term methodology for full committee review and hundreds in the wing to start.

You can see why we are looking for active and committed folks who are willing to roll up their sleeves and help the IECA move forward as the expert organization on erosion and sediment control standards. Lofty goal, we know, but it's good to have goals!


Meet Your New Directors
